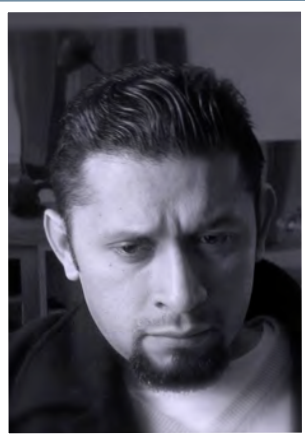

President's Message

I was sure that I had screwed it up, big time.

The children in the refugee camp had decided that they would like to learn how to paint portraits of their grandparents. We met in the middle of the camp, in a field, in the country of Nepal. A goat was nibbling on my pant leg and monkeys scampered along the walls. The children were so excited. That is when I was sure that I screwed it up, big time.

It all started with an Email: "Would you come to Nepal to work with Tibetan Refugees?" I answered "YES."

So, I had quit my job to come to Nepal, and my wife had taken a semester off of school. I had no idea what I would do once we were there, because I wanted to remain open to possibilities. On the flight from Kathmandu to Pokhara, the Maoists had seized the entire country and demanded that no automobiles or electric lights be used by the citizens, on penalty of severe punishment. So when our plane arrived, no car would meet us. Instead, our guide pulled our luggage on a hand-drawn donkey cart, through the deserted streets.

When we finally got to the Tibetan refugee camp, we were greeted warmly by our hosts. We would be living with them in the camp. By candle-light they fed us yak meat, and presented us with a gift reserved only for special occasions: a bottle of orange Fanta. To them, the bottle would have cost a week's wages.

In the morning, I met with all of the children in the camp and was surprised to find that they all spoke English. We decided that we would create a project to honor their elders. They said that they would like to learn how to do portraits of their grandparents. They were excited, buzzing and giddy. We would start painting the next morning! And that is when I screwed up, big time: I said, "Great! Please go home and write an essay about how such a project would contribute to the community of the camp!"

The giddiness stopped. The mood changed. "Oh NO," I thought to myself. I only told them to write an essay because a social worker had suggested it. Oh...no.

The refugee children shuffled to their homes in the camp. I went back to my wife, who asked how the first meeting went. "I screwed up," I said. I asked them to write an essay. I screwed up. Nobody is gonna do this project now. Oh god, I can't believe I screwed up! We came all this way and I turned them off, asking them to write a silly essay!..."

"Wait and see," said my wife. We went to bed.

The next morning at 6 AM there was a knock at our door. I opened it to find a line of children down the road, standing with their parents. The first girl in line came in and read her essay aloud. She had written about honoring people through art. She filled a page about expressing her love for her family. She wrote about how through sacred images and color, she would be proud to become a voice for her scattered people. I sat on the bed listening to her words and my heart pounded. Child after child entered to read their own personal essays. They all expressed their sense of being chosen for something meaningful and honorable...something bigger than them. When all the essays had been read, I promised to meet with them at noon, to begin painting. They all rushed back home, giddy.

We shut the door and sat in silence. Then my wife said, "You were wrong, John Paul. You didn't screw it up."
